

PRIVACY POLICY

In Pharmin we are committed to protect user's privacy and personal data.

Collection and use of Personal Information

In compliance with the provisions of law 18.331, we inform you that the responsible for the database is Gilkenal S.A., sited at Costa Park II Calle San Juan de Capistrano, Ruta 8 Kilometro 17,500, Montevideo and that personal data provided through the website which you could provide in the future as part of your relationship with us, are kept safely on our servers.

You provide and Pharmin collects and uses your personal data to give you information about new product launches and medical publications, as well as other we believe may be of interest. we neither transfer nor communicate in any manner the information you provide to other companies, except for the data that can be sent to third parties for the sole purpose of complying with processing tasks or mail for us and in our name.

Pharmin shall keep the information provided by you only for the period of time that is necessary to fulfill the activities they were collected for. In this respect, data shall be deleted from all systems at Pharmin once they are no longer necessary for the purposes they were gathered for, or in the event their keeping will be no longer necessary, or whether they fall into the terms of the regulations in force.

Security of your Personal Data and Servers

All the information collected on the site shall be treated in compliance with law 18.331 and decree 414/009, will be used solely for the purposes herein agreed and processed with the most stringent security and confidentiality. Pharmin adopts all proper physic and logic security measures in order to ensure the keeping of your data in a safe and private manner, thus preventing their alteration, loss, or unauthorized access and/or processing by third parties.

Pharmin shall lift the confidentiality and reserve only in such cases as required by the law or by a judicial or administrative order.
